**SUBJECT: AUTHORIZATION & APPROVAL TO ALLOW HABITAT FOR HUMANITY JIM HUNTLEY TO LAUNCH SAID WEB SITE "CROW CREEK CONNECTIONS" WEB SITE AND TO USE THE GREAT TRIBAL SEAL "1863" ON THAT WEB PLATFORM**

**WHEREAS:** THE CROW CREEK SIOUX TRIBAL COUNCIL IS THE OFFICAL AND GOVERNING BODY OF AND FOR THE CROW CREEK SIOUX RESERVATION; AND,

**WHEREAS:** UNDER THE CONSTITUTION AND BY LAWS OF THE CROW CREEK SIOUX TRIBE, THE TRIBAL COUNCIL IS EMPOWERED AND AUTHORIZED TO ENACT RESOLUTIONS AND ORDINANCES GOVERNING THE MANAGEMENT OF ALL ECONOMIC AND EDUCATIONAL AFFAIRS AND ENTERPRISES OF THE TRIBE; AND

**WHEREAS:** THE CROW CREEK SIOUX TRIBAL COUNCIL HAS THE AUTHORITY TO REGULATE AND AUTHORIZE ALL COMMERCE, INTERNET COMMERCE, ADVERTISING, AND MEDIA THAT USE THEIR GREAT TRIBAL SEAL: AND,

**WHEREAS:** THE CROW CREEK SIOUX TRIBAL COUNCIL HEREBY, MADE THE MOTION TO AUTHORIZE & APPROVE HANK HENDERSON OF DENNIS, MASSACHUSETTS, COLLECTIVELY WITH JIM HUNTLEY OF HABITAT FOR HUMANITY DACOTAH TIPIS, ON BEHALF OF THE "CROW CREEK CONNECTIONS" WEB PLATFORM HAVE REQUESTED THE USE OF THE TRIBAL SEAL AND THE BLESSING OF THE TRIBAL COUNCIL TO LAUNCH SAID WEB PLATFORM AS DESCRIBED BELOW:

THE CROW CREEK CONNECTIONS WEBSITE WILL EXIST TO SERVE THE COMMUNITY OF THE CROW CREEK INDIAN RESERVATION, BY PROVIDING A LIST OF SERVICES AVAILABLE ON CROW CREEK WITH A DIRECTORY OF LOCAL COMMERCE, ONLINE COMMUNITY BULLETIN BOARDS, CLASSIFIED ADS, A COMMUNITY CALENDAR OF UPCOMING EVENTS AND ACTIVITIES, LISTING OF VOLUNTEERS NEEDED FOR THE LOCAL NON-PROFIT ORGANIZATIONS, AND A WISH LIST PAGE FOR THOSE ORGANIZATIONS.

**WHEREAS:** THIS WEBSITE WILL BE HOSTED AND MAINTAINED AT NO COST TO THE COMMUNITY OF THE CROW CREEK RESERVATION. THIS WILL BE A FREE SERVICE NOW AND IN THE FUTURE; AND,

**NOW THEREFORE BE IT RESOLVED:** THAT THE CROW CREEK SIOUX TRIBAL COUNCIL ASSEMBLED IN REGULAR SESSION THIS 6<sup>TH</sup> DAY OF SEPTEMBER 2011, DO HEREBY MOTION TO AUTHORIZE & APPROVE TO ALLOW HABITAT FOR HUMANITY JIM HUNTLEY TO LAUNCH SAID WEB SITE "CROW CREEK CONNECTIONS" WEB SITE AND TO USE THE GREAT TRIBAL SEAL "1863" ON THAT WEB PLATFORM.
